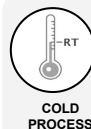

FORMULATION ADVICE: Laboratory scale - 300 g - Defloculator

Weigh phase A ingredients. Add phase B into A. Mix with defloculator at 1200 rpm. Add phase C ingredients one by one, mix for 3 min.
