pH: 5.3 / **VISCOSITIES: 1M at RT:** 675,000 cps Brookfield LV96 @0.6rpm/

Recovery at RT (after 1M at 45°C): 336,000 cps Brookfield LV96 @0.6rpm.

STABILITY: Passed 3 month at RT, 45°C, 3 F/T cycles -5°C/+40°C, & 3 F/T cycles -18°C/RT

FORMULATION ADVICES: Laboratory scale - 300g - Defloculator

Combine phase A and mix well with defloculator. Combine phase B and heat to 75C and then disperse phase C into it. While stirring phase A, add phase BC and mix for 2 minutes (slightly creating vortex). Add phase D and mix until nice emulsion is formed. Then add phase E and mix well. Check pH to make sure it is 5.0-6.5.
